

Application Guidelines — Department of Global Business (Master's Degree Program) of Graduate School of Social Sciences, University of Hyogo in AY2026

1. Admission Policy

We accept applicants who aim to acquire the ability to solve a variety of issues in international business and related domains by obtaining expertise and skills in global business, including business in Japan, as well as cultural competence that will enable them to play an active role on the global stage. Our entrance examination process is focused on selecting students who have experience of studying in an intercultural environment; who possess expertise and skills in this field that are usually obtained in an undergraduate program, as well as language skills that would allow them to take classes conducted in English, and who are willing to use the skills and expertise they obtain within this program for the benefit of the society as a whole. The selection process is conducted entirely in English, involving a comprehensive assessment of application documents, written and oral examinations.

2. Date of Matriculation

April, 2026

(Department of Global Business offers admission in April and September. This admission screening is for enrollment in April.)

4. Application eligibility

Applicants who fulfill any of the following items:

- (1) Those who are expected to graduate from an undergraduate program provided fully in the English language in a faculty or a course or similar at a Japanese university, and who have a recommendation from the dean or the academic advisor of the faculty they are enrolled in.
- (2) Those who have been enrolled for more than three years, excluding leave of absence, in a faculty or a course or similar at a Japanese university in an undergraduate program provided fully in the English language, and who are expected to graduate with excellent grades acquired during their studies (with the exception of class subjects that can only be taken in the fourth year, 80 points or more earned for more than 70% of class subjects necessary for graduation), and who have a recommendation from the dean or the academic advisor of the faculty they are enrolled in.

[Important Points]

If you are unsure of whether you are eligible to apply, contact Academic Affairs Division of Kobe Campus for Commerce before the application period.

5. Application period

- (1) Wednesday, May 28, 2025 to Wednesday, June 4, 2025
- (2) If the documents are sent by regular mail, the application must be postmarked on or before June 4. Please send the documents by registered mail and write "Enc. application for admission to the Global Business" in red on the address side of the envelope.
- (3) Application documents may be submitted in person at the Admissions Office every day from 9:00 a.m. to 3:00 p.m., except Saturdays and Sundays.

6. Application procedures

Enclose the following documents and certificates in an envelope larger than A4 size, with the name and address of the applicant written clearly on the outside, and mail it to Academic Affairs Division of Kobe Campus for Commerce, or bring it directly to Academic Affairs Division.

| (7) Research Proposal | <ul style="list-style-type: none"> • Describe (in English) the subject of your research, your views on the issues in your research field, and the purpose, methods, plan of your research. Approx. 1,500 words, 12 point, single-spaced, Times New Roman/ Arial. • List reference materials in English. However, if the list includes reference materials in Japanese, you do not have to translate the title(s) into English. (The titles of the reference materials are not included in the specified number of words mentioned above.) • Write “Research Proposal” on the first line and your name on the second line. |
| (8) Score Certificate for TOEFL, TOEIC, or IELTS (Original Copy) | <ul style="list-style-type: none"> • Submit an official certificate (only for tests taken on or after April 1, 2023). • If you cannot submit an official score certificate (original copy), submit a document certifying your English language proficiency that has been provided by the English teacher of your university (the last attended school) instead of the score certificates. • MOI is valid, but will not be scored. |
| (9) Letter of Recommendation | <ul style="list-style-type: none"> • The recommendation must be in the specified form in English and signed by the dean or the academic advisor of the faculty. (Submission of a copy is not permitted.) |

[Points to keep in mind]

- 1) If you have a condition that requires help or special consideration at the time of examination and for studying at the graduate school, please contact the Admissions Office of Kobe Campus for Commerce before the application period.
 - 2) If your family name on your family register differs from that on the certificates to be submitted due to marriage or other reasons, please attach an extract of your family register.
 - 3) Applicants are only considered to be complete when the application fee has been paid and all application documents have been submitted.
 - 4) After completing the application, we will not grant any requests for change of materials, or return of the documents, or refunding the application fee. If applicants are unable to submit the original document, submit a certified copy※.
- ※What is a “certified copy” ?
- It is a copy of a document that can be used instead of the original. It must be checked and formally approved as a true and accurate copy by an official such as applicant’s school principal, a notary, or a translation company.
- 5) If any false or distorted information is found in the submitted documents, admission to the graduate school may be withdrawn.
 - 6) Attach an English translation for all documents written neither in Japanese nor in English.
 - 7) Please refer to ‘Faculty in charge of Seminar I & II and their research field,’ given at following URL, and write the

desired specialization and the single name of the advisor with whom you wish to study.

* The nearest station is Gakuentoshi Station of Kobe Municipal Subway, which is an approx. 25-minute subway ride from Shin-Kobe Station on the Sanyo Shinkansen Line, and an approx. 22-minute subway ride (trains bound for Seishin-chuo) from JR Sannomiya Station, Hanshin Kobe-Sannomiya Station, and Hankyu Kobe-Sannomiya Station. It takes about 15 minutes to walk from Gakuentoshi Station to the test site.

8. Admission screening method

Application screening is conducted considering all the factors, including an oral examination and the submitted documents.

9. Examination schedule

(2) Things to keep in mind when taking the admission examination

- 1) Be sure to bring your examination admission card with you on the test date. If you lose or forget to bring the admission card, notify the examination office of the fact before the examination starts.
 - 2) Read the important information written on the backside of the examination admission card in advance.
 - 3) Applicants who arrive after the oral examination start time may not take the examination in principle.
 - 4) Use of your private car to come to the university is not permitted. If you need to drive to the campus due to an unavoidable reason, contact the Admissions Office of Kobe Campus for Commerce in advance.
- (3) The examination will be postponed if the Kobe Local Meteorological Office issues to Kobe City any Warning of Storm, Warning of Snow-Storm, Warning of Heavy Snow, Emergency Warning of Heavy Rain, Emergency Warning of Storm, Emergency Warning of Snow-Storm, or Emergency Warning of Heavy Snow by 7:00 a.m. on the examination date. In this case, we will conduct the admission test on Saturday, July 12, 2025 according to the same schedule.

10. Announcement of successful applicants

10:00 a.m. on Friday, July 11, 2025

The registration numbers of successful applicants will be posted on the bulletin board in Kobe Campus for Commerce of the University of Hyogo, and the university will send a notice to the successful applicants. No notification will be given to unsuccessful applicants. Telephone inquiries regarding the result will not be accepted.

The list of the successful examinees' registration numbers will also be posted on the website prepared by the University of Hyogo. Note that the announcement will be posted on the website as reference. Please check the information regarding the results on the bulletin board of the university or the notice to be sent.

11. Enrollment procedure

- (1) The university will send documents necessary for enrollment to successful applicants. Complete the procedure for enrollment from Wednesday, September 3, 2025 to Wednesday, September 10, 2025. An explanation of the enrollment procedures will be enclosed with the documents.
- (2) For enrollment, the successful applicants will need the following fees and documents, as well as the documents sent from the university with a letter of acceptance.
 - 1) Enrollment fee (Refer to 12. Enrollment and tuition fees.)
 - 2) Examination admission card.
 - 3) Certificate of Items Stated in Resident Register (Only for applicants who are residents in Hyogo Prefecture)
- (3) Accepted applicants who do not complete the procedure for enrollment by the specified date and time will be regarded as having decided not to enroll in the course.

12. MEXT Scholarship

International students for April, 2026 and 2027 enrollment are eligible to apply for MEXT Scholarship (applicants may be subject to restrictions set by MEXT). Each year three students who have passed the DGB entrance examination are selected by the university to receive this scholarship.

*The MEXT Scholarship is a special two-year full scholarship, one of the highest distinctions awarded by the Japanese Ministry of Education, Culture, Sports, Science and Technology (MEXT), with the goal to increase the number of high-performing international students studying in Japan. Remarks;

In order to apply for the MEXT Scholarship, applicants must first pay the application fee and the admission fee to enroll Department of Global Business.

These fees will be refunded to the three students after they are officially approved by MEXT.

【Screening Process】

1st Screening (End of September,2025)

The DGB Steering Committee, consisting of faculty members of the University, will fairly select about 6 applicants who have completed the admission process based on their performance on the entrance examination and our evaluation of their submitted documents. Applicants who pass the first screening will be notified of the details of the second screening, and will be given additional scholarship screening requirements, including a presentation theme.

2nd Screening (End of October,2025)

The Committee will strictly judge applications, checking the level of your presentation, logical thinking ability, and other matters. The screening will be conducted online. The University will select the top three students from the second round and recommend them to MEXT.

Reference : Eligibility for the 2026 academic year

Successful applicants admitted to the DGB April 2026 enrollment who meet MEXT's scholarship requirements, excluding the following:

- Those not from a country that has diplomatic relations with Japan
- Those who have Japanese nationality (including dual nationality, one of which is Japanese)
- Those born on or before April 1, 1991 for 2026 enrollment (April 1, 1992 for 2027 enrollment)

Remarks;

Additional documents are required when applying for the MEXT Scholarship, with particular attention to the following.

- 1) English proficiency score of CEFR B2 or higher in Reading, Listening, Speaking and Writing
- 2) Letter of recommendation (addressed from the dean of your university to the president of the University of Hyogo)
- 3) An abstract of your thesis

13. Enrollment, tuition and other fees

The following are the current enrollment fee and tuition fee. When the rules related to fees are revised, the revised amount of fees will be applied.

*1 A newly admitted student who has had permanent residence in Hyogo Prefecture for at least one year before admission (this also applies if the student's spouse or a first-degree relative has had permanent residence in Hyogo Prefecture), or a graduate student who was enrolled as an undergraduate student at the University of Hyogo before admission to the Master's Program.

*2 Applicants who do not fall into category 1.

*3 Membership fees of Shinshokai Supporters Society and the Society for Academic Promotion (22,000 JPY in total)

The amount of payment may be changed depending on the amount of expenses.

14. Other conditions

- (1) Classes will be held in the daytime from Monday to Friday.
- (2) The conditions of students admitted through special screenings of international applicants after enrollment are the same as those of students admitted through general admission screening and recommendation process.

15. Handling of personal information

- (1) We will handle personal information submitted at the time of application for administrating entrance examinations.
- (2) We will make use of personal information used for admission screening for collection and analysis of the results of admission screening; investigation and research of methods for screening applicants; enrollment procedures; education, such as support for students and learning instruction after enrollment; collection of tuition fees; and other related purposes. We may also provide the names and addresses of successful applicants to the Gakuyukai Alumni Society of the University of Hyogo, the Shinshokai Supporters Society of the University of Hyogo, Tansuikai Alumni Society, and the university cooperative association of the University of Hyogo.
