Graduate School of Information Science, University of Hyogo 2026 PhD Admission Guidelines

I Admission capacity and required qualifications

1 Admission capacity 14 (Department of Data and Computational Science, Graduate School of Information Science)

2 Target Applicants

We are looking for students who are motivated to acquire the necessary skills and knowledge, positively face challenges, and work proactively to contribute to the creation of new social value by make full use of the knowledge and skills of data science and computational science to address issues in a wide range of academic fields, including the natural and social sciences. We accept students who have the abilities required to conduct advanced research in the field of information science, and who have clear objectives and a strong awareness and desire to conduct specialized scientific research.

3 Academic ability requirements

The enrollment policy for the assessment of the abilities and resources required for this program are as follows.

- (1) Possess the enough ability to conduct advanced research in the field of information science.
- (2) Have a clear purpose, strong self-awareness and motivation to conduct specialized research.

4 Standard admission policy

Those who have obtained (or are expected to obtain) a master's degree or professional degree, those who have obtained (or are expected to obtain) a master's degree or a degree equivalent to a professional degree in a foreign country, and those who are enrolled in the Graduate School as working professionals. This is applicable for students from a wide range of fields, including those who have been involved in work related to the research topic. Selection will be based on a comprehensive evaluation of the applicant's information science-related qualifications, specialized knowledge, experience, and ability to promote research through oral examinations, interviews, and screening of application documents such as research plans. In addition, we will determine whether it is possible to provide research guidance and courses in Japanese or English for foreign applicants.

5 Eligibility

Applicants must meet any of the following requirements.

 Those who have a Master's degree or a professional degree (a professional degree prescribed in Article 5-2 of the Degree Regulations (1953, Education Ministry Ordinance No. 9) based on Article 104, Paragraph 1 of the School Education Law. Hereinafter referred to as "professional degree") (including those who are expected to obtain a professional degree by March 31, 2026).

- 2. Those who have been awarded a Master's degree or a degree equivalent to a professional degree in a country outside of Japan (including those who expect to receive such a degree by March 31, 2026).
- 3. Those who have received a Master's degree or a degree equivalent to a professional degree (including those who expect to receive such a degree by March 31, 2026) by completing correspondence courses offered by foreign schools in Japan.
- 4. Those who have completed a course of study at an educational institution in Japan that has been designated by the MEXT as having a foreign graduate school curriculum, and have been awarded a Master's degree or a degree equivalent to a professional degree (including those who expect to receive such a degree by March 31, 2026).
- 5. Those who have completed a course of study at the United Nations University and have been awarded a degree equivalent to a Master's degree (including those who expect to receive such a degree by March 31, 2026).
- 6. Those who have taken an educational course at a school in a country outside of Japan, an educational institution designated under item 4, or the United Nations University, and have passed an examination and screening equivalent to those prescribed in Article 16-2 of the Standards for the Establishment of Graduate Schools and have been recognized as having academic ability equivalent or superior to a person who holds a Master's degree (including those who expect to receive such a degree by March 31, 2026).
- 7. Those designated by the Minister of Education, Culture, Sports, Science, and Technology (MEXT notification No. 118 of 1989) (including those who are expected to fall under the designation by March 31, 2026).
- 8. Those who are recognized by the Graduate School of Information Science as having academic ability equivalent or superior to a Master's degree or a professional degree, and who have reached 24 years of age at the time of admission, based on an individual screening of applicant qualifications.
 - Note: If you have any questions about the eligibility requirements, or if you wish to apply under condition 8, please contact the General Affairs and Academic Affairs Division, Kobe Information Science Campus of the University of Hyogo, by Monday, June 30, 2025.

I Application period and procedures

1 Application period

Applications are accepted from August 4, 2025, to August 15, 2025.

- If the application is submitted in person, please submit from 10:00 to 16:00 (except 12:00 to 13:00). However, the office will be closed from August 13, 2025, to August 15, 2025 due to the holiday.
- Applications are not accepted on Saturdays, Sundays, and national holidays.
- Applications submitted by post must be postmarked by Friday August 15, 2025.

2 How to apply

- (1) Applicants should send the application documents in an envelope with "Application for the PhD Program of the Graduate School of Information Sciences" written in red on the envelope, either in person or by registered mail and by express delivery service.
- (2) Applicants must contact a prospective supervisor in advance to discuss the details of their PhD research and education plan.

1 Selection method

Selection of applicants will be based on document review (application documents), interview, and oral examination.

Note 1 : If the number of applicants is large, some applicants may have to take the exam on the alternative day.

3 Examination subjects

(1) Document review

A research plan of applicants will be reviewed so that they are within the scope of information science. This process also verifies the status of applicants' undergraduate and Master's or pre-doctoral data science and computational science related courses.

(2) Interview and oral examination

The qualifications and abilities of applicants will be comprehensively evaluated so that they are related to information science and are based on the research plan and other documents.

In the oral examination, applicants will be asked to give a presentation on prospective research within a certain time frame. After the presentation, applicants will be asked questions on their expertise and experience in information science.

In addition, for non-Japanese applicants, their Japanese and English proficiency will be assessed so that it does not interfere with their daily research guidance and coursework.

4 Examination venue

University of Hyogo, Kobe Campus for Information Science (see map below). For more information, please check the bulletin board on campus on the day of the examination.

5 Precautions

- (1) Please be sure to bring your examination slip with you and leave it on your desk during the examination. If you forget the examination slip, please report to the admission office and request to be reissued.
- (2) Please be sure to be on time for photo identification of examinees and other procedural instructions.
- (3) If you are late for the scheduled interview time, you will not be allowed to take the examination.
- (4) The use of communication devices (such as smart phones and tablets with phone connections) is strictly prohibited. If you have such devices, please turn them off prior to examination.
- (5) Please secure your accommodation by yourself if overnight stay is required.
- (6) Parking for bicycles, motorcycles and cars are not available. Please use public transportation.
- (7) Smoking is strictly prohibited inside the examination venue.

- Note 1: Category "A" applies if the applicant or their spouse (or relatives of the first degree of kinship) has a resident address in Hyogo prefecture for at least one year before the admission date. Category "A" also applies for candidates who are currently enrolled in the graduate school of the University of Hyogo and international students. Category "B" applies for other applicants.
- Note 2 : Admission fees and tuition are subject to change. If tuition fees are revised during enrollment, the new fees will be applied from the time of the revision (referred as slide system).
- Note 3 : Applicants who continue to enroll from the Master's course at the University of Hyogo are exempt from admission fees (including those who have completed the Master's course at the graduate school of the University of Hyogo and continue to enroll in the PhD course in the middle of the fiscal year 2025).

4 Knowledge expectations prior to admission

It is desirable to have basic knowledge and skills in one or more of the following fields: data science, computational science, health and medical science, and information security science.

- (1) Applicants with disabilities may request special support during examination and studies. Please contact us (details are below) in such cases.
- (2) Once the application procedure has been completed, no changes can be made to the documents and the entrance examination fee is non-refundable.
